Service Contract Terms & Conditions

BE SURE TO REGISTER YOUR SERVICE CONTRACT ONLINE!

In order to maximize Your benefits, please go to <https://devicesupport.microsoft.com> and register Your Service Contract within 10 days of purchase. By registering Your “Microsoft Complete” Service Contract you will automatically apply for the Accidental Damage and Mechanical Breakdown benefit offered by the insurer for certain Plans provided to You pursuant to a group insurance policy We purchased from certain underwriters at Lloyd’s of London. Failure to do so may result in significant service delays when You have a Claim.

CONSUMER RIGHTS: FOR AUSTRALIAN CUSTOMERS, OUR PRODUCTS COME WITH GUARANTEES THAT CANNOT BE EXCLUDED UNDER THE AUSTRALIAN CONSUMER LAW. YOU ARE ENTITLED TO A REPLACEMENT OR REFUND FOR A MAJOR FAILURE OF YOUR PRODUCT AND FOR COMPENSATION FOR ANY OTHER REASONABLY FORESEEABLE LOSS OR DAMAGE. YOU ARE ALSO ENTITLED TO HAVE YOUR PRODUCT REPAIRED OR REPLACED BY US IF YOUR PRODUCT IS NOT OF AN ACCEPTABLE QUALITY OR IF THE PRODUCT FAILURE IS NOT A MAJOR FAILURE. THE BENEFITS OFFERED BY THIS WARRANTY ARE IN ADDITION TO ANY CONSUMER GUARANTEES RELATING TO THE PRODUCT UNDER THE COMPETITION AND CONSUMER ACT 2010 (AUSTRALIAN CONSUMER LAW) AND ANY OTHER STATE AND TERRITORY LEGISLATION. THIS WARRANTY IS AN ADDITIONAL WARRANTY AND ITS TERMS DIFFER FROM THOSE STATUTORY GUARANTEES.

The information contained in this Contract document is intended to serve as a valuable reference guide to help You determine and understand WHAT IS COVERED under Your Contract or is covered by insurance to which you are entitled. DEFINITIONS

Throughout this Contract, the following capitalized words have the stated meaning –

- **“We”, “Us”, “Our”, “Provider”, “Obligor”, “Administrator”**: the party or parties obligated to provide service under this Contract as the service contract provider/obligor, as well as handle the administration under this Contract as the service contract Administrator, who is Microsoft Regional Sales Corp., located at Blk 438 B, Alexandra Technopark, #04-09/12, Alexandra Road Singapore, 119968.
- **“Retailer”**: the seller that has been authorized by Us to sell this Contract to You.
- **“You”, “Your”**: the purchaser/owner of the Product(s) covered by this Contract.
- **“Product(s)”**: the item(s) that You originally purchased, or at Our or the Insurer’s discretion, a Replacement item, that is to be covered under this Contract.
- **“Original Purchase Price”**: the amount paid by You for the covered Product(s); excluding any applicable taxes and/or fees, as indicated on Your Proof of Purchase.
- **“Proof of Purchase”**: the original purchase receipt provided at the point of sale that confirms the date in which the Service Contract and Product were purchased, as well as the Term period and specific Coverage Plan Option.
- **“Term”**: the period of time in which the provisions of this Contract are valid.
- **“Claim”**: a demand for payment against Us in respect to Breakdown Coverage in accordance with this Contract or against the Insurer in respect to Breakdown Coverage in accordance with the Product Disclosure Statement and against the Insurer in respect to Accidental Damage in accordance with the Product Disclosure Statement.
- **“Breakdown”**: the mechanical and/or electrical failure of Your Product to perform its intended function, including defects in materials or workmanship; occurring during normal use of the Product. *Breakdown Coverage for Surface, Xbox, and Microsoft Band Plans is provided to You by Us. Breakdown Coverage for laptop, desktop and tablet plans are provided to You as a benefit pursuant to a group insurance policy We purchased from certain underwriters at Lloyd’s of London. You may access a copy of the Product Disclosure Statement (“PDS”) regarding Accidental Damage Coverage at <http://aka.ms/au-pds>.*
- **“Accidental Damage”**: accidental damage from handling; such as damage resulting from dropping the covered Product, liquid spillage, or in association with screen breakage. *Accidental Damage Coverage is provided to You as a benefit pursuant to a group insurance policy We purchased from certain underwriters at Lloyd’s of London. You may access a copy of the Product Disclosure Statement (“PDS”) regarding Accidental Damage Coverage at <http://aka.ms/au-pds>.*
- **“Repair”**: the actions We or the Insurer take to mend, remedy, or restore Your Product to a sound functioning state following a covered Breakdown. Parts used to Repair the Product may be new, used, refurbished or non-original manufacturer parts that perform to the factory specifications of the original Product.
- **“Administration Fee”**: the amount You are required to pay, per Claim, for certain services covered under this Contract (if any).
- **“Replace” or “Replacement(s)”**: delivery to You of a replacement item in the event We or the Insurer determine Your previous Product is not suitable for Repair. We reserve the right to Replace Your defective Product with a new, rebuilt or refurbished item of equal or similar features and functionality.
- **“Insurer”**: certain underwriters at Lloyd’s of London.
- **“MSRP”**: Manufacturer’s suggested retail price.

SERVICE CONTRACT TERM – EFFECTIVE DATE OF COVERAGE

1. **Coverage for damages to Your Product resulting from Accidental Damage** begins upon Product purchase date and continues for the Term shown on Your Proof of Purchase. *Accidental Damage Coverage is provided to You as a benefit pursuant to a group insurance policy We purchased from the Insurer. You may access a copy of the PDS at <http://aka.ms/au-pds>*

2. **Coverage for a Breakdown** begins upon expiration of the shortest portion of the manufacturer's original parts and/or labor warranty and continues for the remainder of Your Term shown on Your Proof of Purchase. *Breakdown Coverage for Surface, Xbox or Microsoft Band Plans is provided by Microsoft and Claims arising from Breakdown are payable by Microsoft pursuant to the terms of this Contract. Breakdown Coverage for Laptop, Desktop, Tablet, and Smartphone Plans are provided to you as a benefit pursuant to a group insurance policy We purchased from the Insurer. You may access a copy of the PDS at <http://aka.ms/au-pds>*

PRODUCT ELIGIBILITY

In order to be eligible for Coverage (defined below) under this Contract, the merchandise must be: (a) purchased from an authorized Retailer; and (b) not covered for Breakdown Claims for *Surface, Xbox or Microsoft Band* under any other insurance, warranty, guarantee and/or service contract providing the same benefits as outlined herein.

WHAT IS COVERED – GENERAL

During the SERVICE CONTRACT TERM described above, in the event of a covered Claim at Our or the Insurer's sole discretion, this Contract provides labor and/or parts required to Repair the covered Product, or Replacement of the covered Product in lieu of Repair ("**Coverage**").

Coverage described in this Contract does not replace or provide duplicative benefits during any active manufacturer's warranty period. During such period, anything covered under that warranty is the sole responsibility of the manufacturer and will not be considered under this Contract; regardless of the manufacturer's ability to fulfill its obligations.

For Breakdown Claims for *Surface, Xbox or Microsoft Band*, We will Repair or Replace Your Product pursuant to the provisions of this Contract. For Breakdown Claims for *Laptop, Desktop, Tablet, and Smartphone Plans* or Accidental Damage Claims, We are authorised to assess Accidental Damage claims and we will report to the Insurer and authorise repairs. If We, or the Insurer decide to Replace Your Product, technological advances may result in a Replacement with a lower selling price than the previous covered Product, and no reimbursement based on any Replacement item cost difference will be provided. Any and all parts or units Replaced under this Contract become Our or the Insurer's property in their entirety. *When a Replacement is applicable and provided in lieu of Repair, any accessories, attachments and/or peripherals that are integrated with the Product, but that were not provided and included by the manufacturer in the packaging and with the original sale of the covered Product, will NOT be included with such Replacement.*

COVERAGE PLAN OPTIONS

(As indicated on your Proof of Purchase and applicable to You)

1. SURFACE PLAN:

- A) SURFACE PLAN (Breakdown Only)** – If a Surface Plan ("**Plan**") has been purchased (as indicated on Your Proof of Purchase), Coverage includes that which is described in the "WHAT IS COVERED – GENERAL" section above. NOTE: Accidental Damage is not covered under this Plan option.

ADMINISTRATION FEE (Breakdown Only): Under this Plan, no Administration Fee is required.

LIMIT OF LIABILITY – SURFACE PLAN (Breakdown Only): During Your Plan Term, the maximum amount that We or the Insurer is obligated to pay in connection with all Claims pursuant to this Contract is:

- *For Breakdown Covered Claims:*
 - *Aggregate Repair Limit:* unlimited repairs to Your covered Product up to the amount equal to the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Plan ends.
 - *Replacement Limit:* up to one (1) replacement of Your covered Product in the event We determine that the covered Product cannot be repaired. If Your Product has already been replaced once for a Breakdown cause (such as Breakdown due to mechanical/electrical breakdown), Our obligations for Breakdown Coverage will be considered fulfilled and Breakdown Coverage under Your Plan ends.
- *For Accidental Damage Covered Claims:*
 - NOT COVERED.

- B) SURFACE PLAN (Breakdown and Accidental Damage)** – If a Surface Plan ("**Plan**") has been purchased (as indicated on Your Proof of Purchase), Coverage includes that which is described in the "WHAT IS COVERED – GENERAL" section above.

ADMINISTRATION FEE (Breakdown and Accidental Damage): Under this Plan, a \$54.00 AUD Administration Fee per covered Accidental Damage Claim must be paid at the time services are authorized by the Administrator.

LIMIT OF LIABILITY – SURFACE PLAN (Breakdown and Accidental Damage): During Your Plan Term, the maximum amount that We or the Insurer is obligated to pay in connection with all Claims pursuant to this Contract is:

- *For Breakdown Covered Claims:*
 - *Aggregate Repair Limit:* unlimited repairs to Your covered Product up to the amount equal to the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Plan ends.
 - *Replacement Limit:* up to one (1) replacement of Your covered Product in the event We determine that the covered Product cannot be repaired. If Your Product has already been replaced once for a Breakdown cause (such as Breakdown due to mechanical/electrical breakdown), Our obligations for Breakdown Coverage will be considered fulfilled and Breakdown Coverage under Your Plan ends.
- *For Accidental Damage Covered Claims:*
 - *Aggregate Repair Limit:* up to two (2) repairs to Your covered Product up to the value of twice the amount of the Original Purchase Price of the covered Product. For any one covered Claim, the maximum amount that the Accidental Damage benefit covers will not exceed the Original Purchase Price of Your covered Product. Once this aggregate repair limit has been reached, the Insurer's obligations for Accidental Damage Coverage will be considered fulfilled and coverage under Your Plan ends.

- **Replacement Limit:** up to two (2) replacements for Your covered Product in the event We determine that the covered Product cannot be repaired. Once Your Product has already been replaced twice for an Accidental Damage cause, the Insurer's obligations for Accidental Damage Coverage will be considered fulfilled and Accidental Damage Coverage under the Insurer's policy ends. Please see the PDS at <http://aka.ms/au-pds> for details regarding Accidental Damage Coverage.

NOTICE – ABOUT REPLACEMENTS UNDER ANY “SURFACE PLAN” (BREAKDOWN CLAIMS): Determination of whether a defective Product will be Repaired or Replaced is at Our sole discretion. If a Replacement is provided, it will be considered the covered “Product” as referenced in the provisions of this Contract, and if the Term is still effective and the limit of liability has not been fulfilled, Coverage for the Replacement Product will automatically continue for the remainder of the Term. *NOTE: A Repair or Replacement does not extend the Term.*

If We choose to provide a Replacement, We may provide advanced exchange service. If We provide advanced exchange service, the Replacement Product will be delivered to You in advance of Our receipt of the defective Product. IN EXCHANGE, THE DEFECTIVE PRODUCT MUST BE RETURNED TO US WITHIN TEN (10) CALENDAR DAYS OF CONFIRMED DELIVERY RECEIPT OF THE REPLACEMENT PRODUCT. If the defective Product is not returned to Us within ten (10) calendar days of confirmed delivery receipt of the Replacement Product, You will be assessed a non-returned device fee equal to the MSRP of the Replacement Product. WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

NOTICE – ABOUT INSURANCE COVERAGE (ACCIDENTAL DAMAGE CLAIMS): The Accidental Damage Coverage is provided to You pursuant to a group insurance policy We purchased from the Insurer. For Accidental Damage Coverage, the Product Disclosure Statement (PDS) explains the features and benefits of the cover and how to make a claim. You may access a copy of the PDS at <http://aka.ms/au-pds>. The Insurer appoints Us to arrange the Coverage and is liable for the costs of repair and replacement on the terms contained in the PDS subject to payment of Your Administration Fee.

We act as a general insurance distributor on behalf of A.I.S. Insurance Brokers Pty Ltd (AFSL no. 255304) and they have authorised us to arrange Accidental Damage Coverage for our customers. We are not authorised to provide any financial advice in respect of the Accidental Damage Coverage. We are authorised to assess Accidental Damage Claims and we will report to the Insurer and authorise repairs if You have Accidental Damage Coverage.

2. XBOX PLAN (BREAKDOWN ONLY):

If You purchased the Xbox Replacement Plan (“Plan”) as indicated on Your Proof of Purchase, Your Plan provides Breakdown Coverage plus the benefits outlined below for the following components when such components are purchased from a Microsoft Retailer as a single bundle or package:

- One (1) Xbox console Product;
- One (1) Kinect motion sensing device Product; and
- Up to two (2) Xbox standard controller Products.

Replacement Benefits – In the event of a covered Claim, Your Plan provides:

- Up to one (1) Replacement of Your originally purchased Xbox console Product;
- Up to one (1) Replacement of Your originally purchased Kinect motion sensing device Product; and
- Up to two (2) Replacements of Your originally purchased Xbox standard controller Product.

WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

ADMINISTRATION FEE – XBOX PLAN: Under this Plan, no Administration Fee is required.

LIMIT OF LIABILITY – XBOX PLAN: Under this Plan, the maximum amount that We are obligated to pay in connection with all Claims made pursuant to Your Plan is up to the Original Purchase Price of Your Product.

- If Your Xbox console and Kinect motion sensing device have each already been replaced once, You will no longer be eligible for benefits in association with these two Product components of Your Xbox/Kinect system under Your Plan.
- If Your Xbox standard controller Product has already been replaced twice, You will be no longer eligible for benefits in association with this component of Your Xbox/Kinect system under Your Plan.

At any time during Your Contract Term, if We have provided a Replacement Xbox console, a Replacement Kinect motion sensing device, and two (2) Replacement Xbox standard controller Products, Our obligations will be considered fulfilled and all Coverage under Your Plan ends.

NOTICE – NO COVERAGE FOR ACCIDENTAL DAMAGE UNDER THE “XBOX PLAN”: Coverage for damages resulting from accidental damage is not covered and is not available for purchase.

NOTICE – ABOUT REPLACEMENTS UNDER ANY “XBOX PLAN” (BREAKDOWN CLAIMS): Determination of whether a defective Product will be Repaired or Replaced is at Our sole discretion. If a Replacement is provided, it will be considered the covered “Product” as referenced in the provisions of this Contract, and if the Term is still effective and the limit of liability has not been fulfilled, Coverage for the Replacement Product will automatically continue for the remainder of the Term. *NOTE: A Repair or Replacement does not extend the Term.*

If We choose to provide a Replacement, We may provide advanced exchange service. If We provide advanced exchange service, the Replacement Product will be delivered to You in advance of Our receipt of the defective Product. IN EXCHANGE, THE DEFECTIVE PRODUCT MUST BE RETURNED TO US WITHIN TEN (10) CALENDAR DAYS OF CONFIRMED DELIVERY RECEIPT OF THE REPLACEMENT PRODUCT. If the defective Product is not returned to Us within ten (10) calendar days of confirmed delivery receipt of the Replacement Product, You will be assessed a non-returned device fee equal to the MSRP of the Replacement Product. WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR

REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

3. MICROSOFT BAND PLAN (WITH BREAKDOWN & ACCIDENTAL DAMAGE):

If You purchased the Microsoft Band Plan including Accidental Damage (“**Plan**”) as evidenced on Your Proof of Purchase, Your Plan provides straight Product Replacement for covered Breakdown, or Accidental Damage.

ADMINISTRATION FEE – MICROSOFT BAND PLAN: Under this Plan, a \$30.00 AUD Administration Fee per covered Claim must be paid at the time services are authorized by the Administrator.

LIMIT OF LIABILITY – MICROSOFT BAND PLAN: During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion) up to one (1) replacement of Your original covered Product. If Your original Product has already been replaced once for any reason, Our obligations will be considered fulfilled and coverage under Your Contract ends. Please see the PDS at <http://aka.ms/au-pds> for details regarding Accidental Damage Coverage.

NOTICE – ABOUT REPLACEMENTS UNDER THE “MICROSOFT BAND PLAN”: If We choose to provide a Replacement, We may provide advanced exchange service. If We provide advanced exchange service, the Replacement Product will be delivered to You in advance of Our receipt of the defective Product. IN EXCHANGE, THE DEFECTIVE PRODUCT MUST BE RETURNED TO US WITHIN TEN (10) CALENDAR DAYS OF CONFIRMED DELIVERY RECEIPT OF THE REPLACEMENT PRODUCT. If the defective Product is not returned to Us within ten (10) calendar days of confirmed delivery receipt of the Replacement Product, You will be assessed a non-returned device fee equal to the MSRP of the Replacement Product. WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

NOTICE – ABOUT INSURANCE COVERAGE (ACCIDENTAL DAMAGE CLAIMS): The Accidental Damage Coverage is provided to You pursuant to a group insurance policy We purchased from the Insurer. For Accidental Damage Coverage, the Product Disclosure Statement (PDS) explains the features and benefits of the cover and how to make a claim. You may access a copy of the PDS at <http://aka.ms/au-pds>. The Insurer appoints Us to arrange the Coverage and is liable for the costs of repair and replacement on the terms contained in the PDS subject to payment of Your Administration Fee.

We act as a general insurance distributor on behalf of A.I.S. Insurance Brokers Pty Ltd (AFSL no. 255304) and they have authorised us to arrange Accidental Damage Coverage for our customers. We are not authorised to provide any financial advice in respect of the Accidental Damage Coverage. We are authorised to assess Accidental Damage Claims and we will report to the Insurer and authorise repairs if You have Accidental Damage Coverage.

ADDITIONAL BENEFIT INCLUDED IN THIS SERVICE CONTRACT

During the Term, if due to Breakdown, Your Product has three (3) Repairs covered under Your Contract for the same problem and a fourth (4th) Repair is required for the same problem and considered covered under Your Contract (“**Qualifying Service Repairs**”), We will Replace Your Product with one of like kind and quality, but not necessarily same brand, or, at Our sole discretion, provide You with reimbursement equal to the fair market value of the Product as determined by Us based upon the age of the Product and subject to the “LIMIT OF LIABILITY” section. Any Repair services performed while Your Product is under its manufacturer’s warranty period or in relation to accidental damage from handling are not considered to be Qualifying Service Repairs under this benefit.

PLACE OF SERVICE

For all covered Claims, this Contract provides pre-paid shipping of the affected Product to the servicing location designated by the Administrator, as well as shipping of the Repaired Product (or Replacement, if applicable) back to Your registered location on file.

LIMIT OF LIABILITY

In addition to that which is noted in the “COVERAGE PLAN OPTIONS” section as applicable to “Your Plan”, neither We, the Insurer nor the Retailer shall be liable for any incidental or consequential damages; including but not limited to: property damage, lost time or lost data resulting from the Breakdown of any Product or equipment, from delays in service or the inability to render service, or resulting from the unavailability of Repair parts/components. Neither We, the Insurer nor the Retailer shall be liable for any and all Pre-Existing Conditions (defined below) known to You, including any inherent Product flaws.

Please see the PDS for details regarding the limit of liability for Accidental Damage Coverage and Mechanical Breakdown for the Laptop, Desktop, Tablet, or Smartphone Plan.

WHAT IS NOT COVERED – BREAKDOWN EXCLUSIONS

THIS CONTRACT DOES NOT COVER ANY CLAIM IN CONNECTION WITH OR RESULTING FROM:

- (a) **Pre-Existing Conditions incurred or known to You (“Pre-Existing Conditions” refers to a condition that, within all reasonable mechanical or electrical probability, relates to the mechanical fitness of Your Product before this Contract was purchased);**
- (b) **Improper packaging and/or transportation by You or Your representative resulting in damage to the Product while it is in transit, including improperly securing the Product during transportation;**
- (c) **Modifications, adjustments, alterations, manipulation or repairs made by anyone other than a service technician authorized by Us or the Insurer;**
- (d) **Merchandise that is intended for Commercial Use (“Commercial Use” refers to rental, business, educational, institutional or any other non-residential use);**
- (e) **Damage from freezing or overheating;**
- (f) **Normal wear and tear;**

- (g) The intentional or negligent treatment of the Product in a harmful, injurious, malicious, reckless or offensive manner which results in its damage and/or failure;
- (h) Viruses, vandalism, loss, theft, or malicious mischief or disappearance;
- (i) Rust, corrosion, warping, bending;
- (j) Animals (including pets), animal inhabitation or insect infestation;
- (k) Fortuitous events; including, but not limited to: riot, nuclear radiation, war/hostile action or radioactive contamination, environmental conditions, exposure to weather conditions or perils of nature; collapse, explosion or collision of or with another object; fire, any kind of precipitation or humidity, lightning, dirt/sand, smoke, nuclear radiation, radioactive contamination, riot, war or hostile action;
- (l) Lack of performing the manufacturer's recommended maintenance, operation/storage of the Product in conditions outside of the manufacturer's specifications or instructions;
- (m) Improper use of electricity and power fluctuations;
- (n) Merchandise that is subject to a manufacturer's recall, warranty or rework to repair design or component deficiencies, improper construction, manufacturer error or in any case where statutory guarantees under Australian Consumer Law apply;
- (o) Merchandise that has removed or altered serial numbers;
- (p) Any consequential damages or delay in rendering service under this Service Contract, or loss of use or data during the period of time in which the Product is at an authorized servicer or otherwise awaiting parts as authorized by Us or the Insurer;
- (q) Non-Breakdown problems; including but not limited to: imperfections, noises, squeaks or Cosmetic Damage ("Cosmetic Damage" refers to damages or changes to the physical appearance of the Product that does not impede or hinder the Product's normal operational function; such as scratches, abrasions, or changes in color, texture, or finish);
- (r) Normal periodic or preventive maintenance, user education or set up adjustments;
- (s) Any service of the Product that is covered by a warranty, other service contract which is provided by someone other than Us;
