

## **'Summer Campaign 2011 Quiz' COMPETITION RULES**

**1.**

The 'Summer Campaign 2011 Quiz' competition (hereinafter referred to as 'the competition') is a competition without purchase obligation organised by Microsoft Belux, having its registered office at Corporate Village | Da Vincilaan 3 | 1935 Zaventem, and is subject to the conditions specified in these competition rules and in the Belgian law.

**2.**

The competition lasts 8 weeks, from 05/07/2011 00:00 to 31/08/2011 23:59.

The winners are determined and the prizes awarded based on who gave the most correct answers. There will also be a tie-breaker question to determine the exact winners in case of several winners.

**3.**

In case of a tie the highest prize is awarded to the person who was the first to complete the competition (based on date and time).

Microsoft Belux can exclude a person from entering the competition for a definite period at any moment in case of a breach of one of the entry conditions or in case of misuse, deceit or bad faith.

**4.**

The answers need to be registered on 31/08/2011 at 23:59 at the latest via the underlying tool coupled with every Quiz question. Also you need to be registered for one of our technical newsletters.

Only the answers registered at that time from the people that are registered at one of our technical newsletters are taken into consideration to determine the winners. Incomplete answers or answers registered after 31/08/2011 at 23:59 hours via the aforementioned tool shall be considered as invalid. Microsoft Belux cannot be held liable for lost information or delays caused by Internet providers.

**5.**

Only adults and companies living/established in Belgium may enter the competition, with the exception of Microsoft Belux staff members and relatives of Microsoft Belux staff living at home, as well as the design and advertising agency with whom the competition was launched and the Microsoft Partners. Entry to the competition implies full and unconditional acceptance of all provisions of these rules, and any decision related to the competition of Microsoft Belux.

**6.**

Monitoring of the regular nature of the competition, the strict application of the rules, the indication of the winners, the awarding of the prizes and the sending or handing over of the prizes is exercised by Microsoft Belux against whose decisions no recourse is possible.

Every physical participant can only win 1 prize, irrespective of the number of aliases with which he/she has entered the competition.

**9.**

The participant must, on pain of disqualification, register fully and correctly on the website with the company name, name, first name and e-mail address. All the fields of the registration page need to be entered. Any

person who has registered in this way is able to enter the competition. Anonymous, incomplete or incorrect entries are not accepted. The winners of the competition will be notified personally on 30/09/2011 at the latest.

**10.**

If the participant adds a signature, this signature becomes Microsoft's property. Microsoft reserves the right, as it sees fit, to clean up, shorten, change or remove this entry/contribution, without (prior) warning.

Microsoft is given the perpetual right to use your entry/contribution, albeit amended or not, for any medium whatsoever for free. Microsoft is not obliged to specify your name.

**11.**

The prize is personal and non-transferable. It cannot be exchanged in any way whatsoever, including any monetary value or other goods or services.

**12.**

Entry to the competition with the use of certain programs, outside the program of the website itself, and all changes/adjustments to the latter program, are prohibited and shall result in disqualification of the participants in question. The organising company reserves the right to disqualify people who try to cheat or disrupt the competition or do not observe the current rules. Where applicable, the winner will not be entitled to a prize.

**13.**

Through their entry, the candidates to the competition explicitly agree with these rules and regulations and declare to have taken note of the Terms and condition of use and the Privacy statement of the aforementioned website.

**14.**

Microsoft Belux is not liable for any material mistakes or the consequences thereof.

**15.**

There will be no communication whatsoever regarding this competition during the course of the competition; entry to the competition in any other way than the internet page is not possible.

**16.**
